Emergency Notification System "UVA Alert"	Emergency alert to warn of imminent threat on Grounds and action to take	Triggered by an emergency currently occurring or immediately threatening the health/safety of students or employees who are on Grounds	Issued immediately upon confirmation that a dangerous situation or emergency currently exists	UVA Alert	<ul> <li>Tornado warning</li> <li>Gas leak</li> <li>Armed intruder</li> <li>Chemical/hazardous materials spill</li> <li>Fire/explosion</li> </ul>	<ul> <li>Text message (opt-in <u>UVA Alerts</u>)</li> <li>Text to general public (opt-in via texting "UVA" to 226787)</li> <li>Email to all current students, faculty, staff and UVA Health Team Members with an active "@virginia.edu" address (including foundation employees who have registered UVA email accounts)</li> <li>"UVA Alert" in email subject line</li> <li><u>UVA website homepage</u></li> <li><u>Alertus Desktop Notification</u></li> <li><u>Rave Guardian</u> mobile safety app</li> <li><u>UVA Emergency Management website</u></li> <li>Siren/ public address system</li> <li>LED and LCD signs on Grounds</li> <li><u>UVA EM,</u> @UVAPolice, @HoosSafe on Twitter</li> </ul>
Community Alert (Timely Warning)	Notify the University community about crimes or incidents that pose a serious and ongoing threat to safety	Triggered by a <u>crime/incident that has</u> <u>already occurred and been reported</u> within the University community as prescribed by the <i>Clery Act</i>	<ul> <li>Issued when UVA determines a crime/incident represents a serious or continuing threat to students and employees</li> <li>Issued as information is available to enable people to make informed decisions to protect themselves and prevent similar crimes</li> <li>Not sent for every crime</li> <li>Will not be sent if sending will impact an ongoing investigation</li> </ul>	Associate Vice President for Safety and Security and Chief of Police	<ul> <li>Crimes of the person (homicide, aggravated assault, rape, sexual assault)</li> <li>Property crimes (robbery, burglary, motor vehicle theft)</li> <li>Violence Against Women Act offenses (intimate partner violence, stalking)</li> <li>Hate crimes</li> <li>A Clery crime occurring outside the Clery "geographic area," but in an area where students frequent</li> <li>Non-Clery crime occurring on-Grounds</li> </ul>	<ul> <li>Email to all current students, faculty, staff and UVA Health Team Members with an active "@virginia.edu" address (including foundation employees who have registered UVA email accounts)</li> <li>"Community Alert" in the subject line</li> <li>Generally issued via email, but may also be distributed through press releases, text messages, posters, desktop alerts and with messages on UPD's website when appropriate</li> </ul>
Community Advisory	Awareness about safety issues	Sharing information about safety issues; acknowledging event and providing notice that UVA is monitoring	Issued as aware	EVP-COO or University of Virginia	<ul> <li>Acknowledgement that a widely-known threat or condition is being monitored</li> <li>Modifications to operating schedule</li> </ul>	<ul> <li>Email to all current students, faculty, staff and UVA Health Team Members with an "@virginia.edu" address (including foundation employees who have registered UVA email accounts)</li> <li>"Community Advisory" in the subject line</li> <li>Post on official UVA social media accounts if needed</li> </ul>
